The number plaques for the allotments are in progress, with The Meadows already complete. If your plot gets an incorrect number, please let the clerk know!

Our Parish Warden has been very busy cleaning graffiti off many items around the village. This means he cannot keep up with the Spring jobs we have for him. The police have been informed about the incidents and if you have any information, please contact them or the clerk.

The cost of moving the gates at The Meadows has been agreed and the council is awaiting confirmation of a date for the work to be carried out.

There has been no further progress with the hiring options of the MUGA (multi-use games area).

Information to support a speed reduction on the 40mph northern section of Norwich Road is being collected.

An application to register The World's End Public House as an Asset of Community Value has been submitted. South Norfolk Council are considering this and will advice the Parish Council in May if this has been successful.

A request for additional "Duck" warning signs has been sent to Highways.

The Scouts have removed part of the hedge and installed a gate as agreed at April's meeting. Thank you to the Scouts for keeping us informed.

Cadnet Gas have confirmed that there is no requirement for the SAM2 post on Norwich Road to display any notice containing information about the nearby gas pipeline.

The specification for disabled access to the Village Hall site is being discussed with the Common Steering Group and the Parish Warden

Item 13: Common Steering Group

The Common Steering Group meet on 24 April. The group agreed the council should focus on moving dog bin/benches, installing a memorial bench and the disables access to the village hall. The next meeting is scheduled for 23 October.

Item 14: Litter pick on Saturday 20 April

Item 16: Community Project

The council, in collaboration with South Norfolk Council, were successful in achieving funding through the Pride in Place Community Grant. This grant, along with a contribution from the Parish Council, is being used to fund a feasibility study to help us understand how best to use the village hall and parks site. The consultant is in the process of collecting the data and speaking to the groups who use the site. The study is due to be completed in August, but we hope to be able to give you an update at the Annual Parish Meeting on 17 June, at Hannover Gardens.

Item 17: SAM2 data

SAM 2 data is now available on our Facebook page as well as our website.

Item 18: Annual Parish Meeting

Item 21: Plans of Oakley Park South and Long Lane allotments

The plans signed by the council, to enable the transfer of land, where not drawn to scale. Solicitors are requesting the council sign replacement plans.

Item 22: Grass cutting of verges at Minnow Way

Last year the council received complaints about the lack of grass cutting of Minnow Way. The Parish Council do have a delegated grass cutting agreement with Norfolk County Council but there has been no correspondence about adding this to the regime.

Item 24: Martyn's Law

Martyn's Law, also known as The Terrorism (Protection of premises) draft bill, is expected to improve the safety and security of public venues and keep the British public safe from terrorism. A consultation aimed at standard tier premises (premises with a capacity of 100-799 individuals) closed on 18 March. No further information has been issued on the results of the consultation.

Item 25: Uncultivated plots at The Meadows allotments

Following an inspection of the allotments, the clerk contacted 3 tenants about the condition of their plots. It is a requirement that the plots are cultivated and in some cases this is not happening.
